## **I. Call to Order & Invocation**

**Madame President Nuttle** called the meeting to order at 5:40 pm. Secretary Gardipe gave the invocation.

## **II. Roll Call - Declaration of Quorum**

**Secretary George Gardipe called the roll:** Misty M Nuttle – here, Jordan Kanuho – here, George Gardipe – here, Carol Chapman – here, Cynthia Butler – here, Dawna Hare – titaku (here), Carol Nuttle – here, and Jenifer Gover-LittleSun – here. **Quorum established.**

## **III. Approval of Agenda**

Motion made by Carol Nuttle to approve the Pawnee Business Council Special Meeting agenda for June 17, 2025, seconded by Cynthia Butler.

## **IV. Approval of Minutes**

### **1. Approval of Pawnee Business Council Special Meeting Minutes for April 15, 2025**

Motion made by Dawna Hare to table the Pawnee Business Council Special Meeting Minutes for April 15, 2025, seconded by Cynthia Butler.

Vote: Jordan Kanuho– yes, George Gardipe– yes, Carol Chapman– yes, Cynthia Butler- yes, Dawna Hare- ahu (yes), Carol Nuttle– ahu (yes), Jenifer Gover LittleSun – yes, and President Nuttle – not voting. Motion carries.

## **V. Pawnee Business Council Travel Report & Request**

The following reports were given:

Councilwoman Gover LittleSun reports on SPTHB Tribal Leaders Convening & Town Hall meeting with Congressman Lucas:

- Discussed significant cuts to tribal law enforcement (\$140M), Indian education (BIE facing \$187M reduction), and LIHEAP (\$4B cut), emphasizing the cascading effects on tribal communities.
- Raised concerns about a new DOJ policy requiring approval for POs over \$10,000, potentially limiting program autonomy.
- Shared that the National Indian Health Board provided template letters and talking points for tribal advocacy.
- Suggested forming a caucus to coordinate tribal legislative efforts.
- Informed Congressman Lucas about Oklahoma's exclusion from IHS consultations; he expressed support and requested a white paper.
- Discussed the impact of potential Department of Education closure on tribal gaming revenue allocations.
- Highlighted how disability income disqualifies veterans and elders from food assistance.
- Will forward a full written report to the Council.

Councilwoman Butler reports on Sovereignty Symposium:

- Attended panels on international indigenous trade and free trade zones.
- Learned about protecting Native American arts and crafts through trademarks and copyrights.
- Discussed the implications of AI on cultural authenticity and the need to protect human-created content.
- Recommended trademarking the Pawnee Nation seal, a long-standing goal.

Secretary Gardipe reports on Sovereignty Symposium:

- Focused on economic development and networking with other tribal leaders.
- Emphasized the need for tribes to create independent revenue streams.
- Participated in posting the colors for the first time.

Councilwoman Hare reports on Sovereignty Symposium:

- Attended a panel on tribal-state partnerships moderated by Oklahoma Labor Commissioner Leslie Osborn.
- Accidentally attended a powerful session on language preservation; advocated for using Pawnee in council meetings.
- Participated in discussions on indigenous control over digital infrastructure and data.
- Attended a session on the history of the Sovereignty Symposium and key figures in Indian law.
- Will submit a detailed written report.

Councilwoman Carol L. Nuttle reports on SPTHB Tribal Leaders Convening:

- Advocated for the CHAP (Community Health Aide Program) initiative.
- Emphasized the need for local training and certification to support tribal health services.
- Reported on a national CHAP conference and upcoming presentation.

President Nuttle reports on SPTHB Tribal Leaders Convening, Town Hall with Congressman Lucas, and the Oklahoma Economic Impact Study:

- Stressed the importance of engaging in consultations and holding federal agencies accountable.

- Shared findings from a study showing tribes contribute \$23.4B in goods/services and support nearly 140,000 jobs in Oklahoma.
- Discussed efforts to bring CHAP training to Oklahoma and the need for collaboration with medical professionals.
- Advocated for educating tribal citizens on legislative processes and civic engagement.

The following travel requests were submitted:

Councilwomen Nuttle, Hare, and Gover LittleSun all requested to attend the United Indian Nations of Oklahoma Quarterly Meeting on Tuesday June 24<sup>th</sup> in Oklahoma City.

Councilwoman Gover LittleSun requested to attend the ACA/IHCIA training on Wednesday June 18<sup>th</sup> and Thursday June 29<sup>th</sup> in Tulsa, OK.

Motion made by Cynthia Butler to approve the Pawnee Business Council Travel Requests, seconded by George Gardipe.

## **VI. Pawnee Business Council Committee Reports**

Dawna Hare mentions the following:

- Committees have not been meeting due to quorum issues.
- Awaiting orientation and potential reappointments before resuming meetings.
- Notes for the Intergovernmental Affairs Committee
  - Thanked Congressman Lucas for his past support in securing \$19.4 million for the Pawnee Health Center.
  - Recounted multiple advocacy trips to Washington, D.C., with President Chapman to secure funding.
  - Emphasized the importance of persistent advocacy and follow-up in securing federal appropriations.
  - Suggested compiling a packet detailing the history and process of securing the Pawnee Health Center funding.
  - Advocate for civic education to help tribal citizens understand how to engage in federal processes.

There was also discussion on developing Tribal civics and history classes to educate Tribal members and the importance of effectively engaging with lawmakers.

## **VII. New Business**


