- Collaborating on seasonal events like the Fall Equinox Feast.
- Funding assistance for the Veterans and Christmas dances.
- Offering support for tribal events (e.g., flag bearers at funerals and inaugurations).

## **VII. Open Forum**

Liana Teter commented on the following:

- When and how the proposed amendments (A-T) would be presented to tribal members.
- How many opportunities there would be to learn about the changes before voting.

Joe Buford and Michelle Reed reported on the following:

- Requested a formal commitment from the council to meet with the Seed Preservation Society to address internal issues and promote unity.
- Ancestral corn seeds were “held hostage.”
- Over \$5,000 in property was mishandled.
- Acting as a whistleblower and requested a letter of support and acknowledgment.

Angela Thompson objected to the new 3-minute limit for public comments, stating it restricts tribal members' voices and may violate constitutional rights.

Treasurer Carol Chapman supported this concern and added that she felt censored during a previous meeting when her microphone was cut and her comments were removed from the YouTube recording.

Denise Miller criticized Treasurer Chapman for refusing to release funds approved by the council, emphasizing that the council is the supreme governing body and its decisions must be followed.

Ella Blackowl commented on the following:

- Lack of transparency from the Seed Preservation Society (e.g., meeting notices, board changes).
- Council members attending meetings virtually while participating in powwows.
- Inconsistent participation in the Constitution Convention by council members.

The Pawnee Business Council Quarterly Meeting has been scheduled for August 2, 2025, at 9:00 am at the Multipurpose Building.

The next Pawnee Business Council Special Meeting has been scheduled for August 5, 2025, at 5:30 pm at the Multipurpose Building.


### **IX. Adjournment**


