Secretary Gardipe mentions his committee will be pushing for an initiative for a tribal deer hunt, archery only. Working on the specifics and will be coming to the council soon for approval.

Councilwoman Gover-LittleSun thanked Secretary Gardipe for pushing the tribal deer hunt.
